The list of foreign exchanges, which meets the criteria of Bank of Russia Ordinance No. 5312-U, dated 11 November 2019, 'On the Criteria to Be Complied With By a Foreign Exchange Where the Listing of Securities Underlying Russian Depository Receipts is Mandatory for Issuing Russian Depository Receipts Whereunder the Issuer of Underlying Securities Undertakes No Obligations to Holders of Russian Depository Receipts, or Where the Listing of Foreign Issuers' Securities Has Been Commenced or Completed, Except Securities of International Financial Institutions, for a Russian Exchange to Make a Decision on Whether to Admit Them to Exchange Trading'

Pursuant to the clause 4 article 27.5-3 and clause 4 article 51.1 of the Federal Law No. 39-FZ, dated 22 April 1996, 'On the Securities Market', Bank of Russia Ordinance No. 5312-U, dated 11 November 2019, 'On the Criteria to Be Complied With By a Foreign Exchange Where the Listing of Securities Underlying Russian Depository Receipts is Mandatory for Issuing Russian Depository Receipts Whereunder the Issuer of Underlying Securities Undertakes No Obligations to Holders of Russian Depository Receipts, or Where the Listing of Foreign Issuers' Securities Has Been Commenced or Completed, Except Securities of International Financial Institutions, for a Russian Exchange to Make a Decision on Whether to Admit Them to Exchange Trading' establishes the criteria to be met by a foreign exchange, passing the listing procedure where securities represented by Russian depository receipts are a condition for issuing Russian depositary receipts, for which the issuer of underlying securities does not assume obligations to holders of Russian depositary receipts, or at which the procedure for listing securities of foreign issuers was initiated or completed, with the exception of securities of international financial organizations, for the Russian stock exchange to decide on their admission to organized trading.

The criteria, established by the Bank of Russia Ordinance No. 5312-U, dated 11 November 2019:

1. A foreign exchange where the listing procedure for securities represented by Russian depositary receipts is a condition for issuing Russian depositary receipts, for which the issuer of the underlying securities does not assume obligations to the holders of Russian depositary receipts, or a foreign exchange where the procedure for listing securities of foreign issuers, except securities of international financial organizations, for a Russian exchange to make a decision on their admission to

organized trading (hereinafter collectively referred to as a foreign exchange) must meet at least one of the following criteria:

- 1.1. A foreign exchange is a member of the World Federation of Exchanges and (or) the International Association of Exchanges of the Commonwealth of Independent States, except for cases of associated membership of a foreign exchange in the organizations specified in this subclause.
- 1.2. The place of incorporation of a foreign exchange is the state specified in subclauses 1<sup>2</sup> and (or) 2<sup>3</sup> clause 2 article 51.1 of the Federal Law 'On the Securities Market'.

Under the Bank of Russia Ordinance No. 5312-U, dated 11 November 2019, the Bank of Russia <u>publishes</u> the list of foreign exchanges, which meets the abovementioned criteria (please see further Table 1 below).
